SUMMARY OF CONTRACT PROVISION**

WITNESSETH: that in consideration of the mutual covenants and agreements to be kept and performed on the part of said parties hereto, respectively as herein stated, that **Altec Solutions Group, Inc.** does hereby covenant and agree that it shall:

1. ASG will act as a **Seller Agent**: We make a professional appraisal of the equipment value:
 - ASG will show past trading activity and determine with the client the market value selling price.
 - ASG will inventory and warehouse the equipment, if requested.
 - ASG will represent equipment as accurate and truthful as possible. We will answer all perspective buyers' questions or concerns.
 - ASG will provide a Month End Received Report of all assets received. We will provide a Month End Sales Report detailing all assets sold or recycled.
 - ASG will arrange payment escrow services if requested. We will handle the logistic of packaging and shipping of the equipment.
 - ASG will be responsible for all advertising cost. Our fees are to be paid upon completion of the sale is (amount agreed) ____% of the total sale price of the equipment minus transportation cost of equipment from customer site to our warehouse in Springfield, MO.
2. Delivery of the Owner's Equipment shall at its own expense be delivered to ASG's warehouse
3. Risk of Loss Owner shall deliver the Equipment to ASG, Free On Board Agent's place of business set forth above, and risk of loss for the Equipment shall pass to Agent upon Agent having received, inspected, inventoried and acknowledged receipt of the Equipment by returning a signed copy of a Remarketing Schedule to Owner.
4. Warranty of Title Owner should represent a free and clear title to all Equipment delivered to ASG hereunder, of all security interests, mortgages, liens, pledges, claims, charges or encumbrances.
5. ASG's Compensation for remarketing services performed, Owner Agrees to pay ASG's Fee for the amount agreed above of ____% of final sale.
6. Termination may only be enforced upon thirty (30) days prior written notice from the party terminating to the other party. Termination shall be effective thirty (30) days from receipt of the required notice. ASG shall promptly return to Owner all (or any portion) of the Equipment listed which has been terminated hereunder upon Owner reimbursing ASG for all reasonable expenses incurred by ASG in connection with the storage, shipping and marketing of such Equipment.

7. Other terms to be observed by and between the parties:

This agreement shall be binding upon the parties, their successors, assigns and personal representatives. Time is of the essence in all undertakings. This agreement shall be enforced under the laws of the State of Missouri. This is the entire agreement.
